- e) Premises committee (ad-hoc sub-committee of Full Governing Body, meeting as necessary and annually for a premises inspection).

KEY ISSUES ADDRESSED BY THE GOVERNING BODY DURING THIS PERIOD	IMPACT ASSESSMENT
The Pupil Performance Committee has closely monitored the introduction of the revised National Curriculum.	The work of the committee on behalf of the Governing Body has ensured that the school is well placed to deliver the raised expectations within the revised National Curriculum and is confident that the work undertaken by the teaching team will lead to the school delivering higher standards of achievement for pupils within a two-year period.
Increasing the capacity of our Inclusion Team to support pupils and families which are facing challenges of any sort.	The governors approved the recommendation from the Leadership Team that, in order to address emerging challenges arising from the change in the school's demographic; the Inclusion team would be made up of three full time members of staff. The pupil performance committee has seen evidence of the impact of this improvement to provision and the Leadership Team report an increase in the number of pupils supported to enable them to make progress. Pupils who benefit from Pupil Premium funding make good or better progress.
Ensuring that the established school ethos is maintained and that "British Values" are effectively recognised.	Despite substantial changes to the statutory requirements placed on schools nationally, the governors are confident that the positive and inclusive ethos has been maintained. Further work is planned to integrate the relatively new requirements within the existing curriculum plans.
The Finance and HR Committee has focused on ensuring that real-term budget cuts have not had an adverse effect on service delivery.	The Governors prepared an "austerity budget" to make sure that they could meet the challenges of budget cuts whilst supporting the Headteacher to make in-year savings. As a result of this prudent action, the school was able to maintain staffing levels for teaching and learning into 2016/17 and ensure that the school did not have a significant deficit within the longer term budget plans.
The Pupil Performance Committee have scrutinised plans to introduce a new assessment system following the removal of levels.	The committee report that the school is well placed to track the progress and attainment of all pupils following the adoption of STATOnline as a product. The committee has shaped the reporting methods to ensure that the successes of the previous system are retained and that the opportunities within the new system are fully embraced.
